FUNWORKS! Day Camp program is an organized play group that provides structured play time and free play time for children ages 6 – 13 years old who purchase a Day Camp wristband. FUNWORKS! is not a day care, nor does it provide day care services.

FUNWORKS! Day Camp program operates at FUNWORKS! in Modesto and is open from 7:30 a.m. until 6 p.m. In order to attend the Day Camp program, parents must fill out all required paper work and pre-pay all program fees. Two weeks notice needs to be given by the parents to FUNWORKS! in order to withdrawal your child or children from the program.

FUNWORKS! will not administer medication to children attending the program. If your child requires a medication dosage during the program time, please return to FUNWORKS! to administer the medication. If your child carries medication (i.e. inhaler for asthma, etc.) and can self-administer the medication, they need to carry with them a Physician's note detailing the medication, condition and prescribed dosage. FUNWORKS! staff will not administer medication for the child under any circumstances.

If your child hurts himself or herself and professional medical attention is required or FUNWORKS! staff feels that it is needed, you will be the first to be notified. After every attempt is made to notify you and we are unable to reach you, emergency medical services will be contacted. If the situation is life threatening, emergency medical services will be contact first.

Every child who attends the program will need to be signed in when arriving and signed out when leaving the program. If someone other than yourself will be dropping off or picking up your child, please list them on the registration forms. When the child is picked up a full signature will be required as well as identification confirmation that they are on the approved pick up list.

It is expected that all participants in the Day Camp program will adhere to FUNWORKS! code of conduct, which includes that they will not: wear any clothing that displays drug paraphernalia, no tobacco use, no profanity, no alcohol, no pets, no outside food or drink, no skates, no offensive attire, no gang attire or no sagging pants.

Discipline will be handled in the following ways: verbal warning, removal from activity, conference with parent. No corporal or verbal punishment is permitted. We honor the personal rights of all. Your child will be asked to leave if they use inappropriate language or actions and conferences with parents have not alleviated the situation.
